



## **COVID-19 PROTOCOL**

ALL RETURNING, AND NEW, STUDENTS MUST COMPLETE A COVID DECLARATION BEFORE BEING ALLOWED ACCESS TO THE LODGE. YOU MUST ALSO MAKE EVERY EFFORT TO OBTAIN A VACCINATION IF YOU HAVE NOT ALREADY DONE SO. THE LODGE NEEDS TO KEEP ITS STAFF AND RESIDENTS SAFE AND A VACCINATION IS THE MOST APPROPRIATE METHOD FOR DOING SO. IT COULD CONSEQUENTLY BE MADE COMPULSORY BY THE LODGE.

1. IF YOU HAVE BEEN IN CONTACT WITH A POSITIVE PERSON WITHIN 10 DAYS OF ARRIVING AT THE LODGE, DO NOT RETURN UNTIL THE 10 DAYS ARE UP, YOU HAVE NO SYMPTOMS, AND ARE TESTED NEGATIVE
2. ONCE AT THE LODGE, YOU WILL BE REQUIRED TO FOLLOW THE REGULATIONS WITHOUT EXCEPTION :
  - a. WEAR MASKS AT ALL TIME WHEN IN PUBLIC
  - b. SANITIZE YOUR HANDS OFTEN
  - c. DO NOT TOUCH YOUR MOUTH, NOSE OR EYES
  - d. KEEP YOUR DISTANCE – AT LEAST 2M IS REQUIRED
  - e. IF YOU HAVE ANY SYMPTOMS, IMMEDIATELY QUARANTINE YOURSELF, GET TESTED AND INFORM MANAGEMENT.
  - f. STAY IN YOUR OWN LODGE
  - g. OBEY THE CURFEW TIMES
3. **IF YOU TEST POSITIVE,**
  - a. IF YOU HAVE SYMPTOMS AND/ OR ARE ILL :
    - i. YOU WILL BE REQUIRED TO RETURN HOME AS WESTWOOD LODGE DOES NOT HAVE THE MEDICAL FACILITIES, OR EXPERTISE, TO TAKE CARE OF YOU
  - b. IF YOU HAVE NO SYMPTOMS :
    - i. YOU WILL BE REQUIRED TO SELF-ISOLATE FOR 10 DAYS FROM WHEN THE SYMPTOMS FIRST APPEARED. WESTWOOD LODGE HAS SET ASIDE ONE LODGE ONLY FOR THE PURPOSE OF ISOLATION BUT IF IT IS FULL, YOU WILL BE REQUIRED TO RETURN HOME TO ISOLATE.
  - c. ENSURE THAT YOU INFORM ALL THE PEOPLE YOU HAVE BEEN IN CONTACT WITH THAT YOU HAVE TESTED POSITIVE SO THAT THEY TOO CAN QUARANTINE FOR 10 DAYS.
  - d. ONCE YOU HAVE ISOLATED FOR 10 DAYS, OR HAVE HAD A NEGATIVE TEST, YOU MAY RETURN TO YOUR LODGE
4. **IF YOU HAVE BEEN IN CONTACT WITH A POSITIVE PERSON :**
  - a. YOU MUST QUARANTINE FOR AT LEAST 10 DAYS
  - b. YOU MUST COMPLETE A DAILY SELF-MONITORING FORM
  - c. IF YOU DEVELOP SYMPTOMS, YOU MUST SEEK MEDICAL ASSISTANCE AND ISOLATE
  - d. IF YOU DO NOT DEVELOP SYMPTOMS, YOU MUST STILL QUARANTINE FOR THE FULL 10 DAYS, OR UNTIL YOU HAVE TESTED NEGATIVE BEARING IN MIND THAT TESTING SHOULD ONLY OCCUR ON DAY 7, OR THEREABOUTS, AFTER CONTACT

ANY PERSON WHO DOES NOT FOLLOW THE PROTOCOL, OR WHO DOES NOT INFORM MANAGEMENT, WILL BE ASKED TO IMMEDIATELY LEAVE THE LODGE. WE WISH TO KEEP OUR RESIDENTS AND STAFF SAFE AND YOUR CO-OPERATION, AND ASSISTANCE IS REQUIRED. YOU ARE ALSO SOLELY RESPONSIBLE FOR DOING THE “RIGHT THING”, AND FOR FOLLOWING THE REGULATIONS, AND PROTOCOL.
